- If you have more than five vehicles, enter the additional vehicles on a separate sheet using the same format as listed, i.e., list the make, then year, model, number of cylinders, body style and condition.
- Vehicle Condition Codes:** 'A' Restored; 'B' Original; 'C' Under Restoration; 'D' Restorable; 'E' Parts Car. **If the vehicle meets the VCCC Criteria for listing as Modified, put the letter M in front of the Condition Code.**
- Show 'Make' as full name, e.g. Chevrolet, not Chevy, and 'Body Style' as 4 Door Sedan, 2 Door Sedan, Coupe, etc.
- List only vehicles that are **AT LEAST** 25 years old.
- This form must accompany your payment to your Chapter treasurer. Make cheques payable to The Vintage Car Club of Canada (VCCC).

**MODIFIED CARS:** Effective May 8, 2021 the VCCC Roster can include modified vehicles that fit the following criteria:

1. Vehicle must be of "ancient age", defined as 25 years or older, with a focus on preservation.
2. Vehicle modifications may include those to mechanical components, which enhance the safety or reliability of the vehicle.
3. The outward appearance of the vehicle must appear stock, to a layperson.
4. Period correct aftermarket/dealer accessories will not trigger modified status.
5. Modified vehicles will be designated in the roster by the letter M, followed by their condition code.
6. Modified vehicles will not be eligible for judging at the May Tour.
